TEXT OF THE OUTGOING PRESIDENT'S REPORT

Any progress and success that has been made by the Kentucky Society during the past year is due to the zealous efforts of the Board of Directors, other officers, the Executive staff and the various Committees. To all who have so worked, I am deeply grateful.

If there was any notable accomplishment during the year, I believe it was the sustained harmonious relationship that the accountants of Kentucky have with each other and with the American Institute. These relationships have been a notable accomplishment for several years and a continuation of that condition is most gratifying. Several times during the past year, there were full demonstrations that professional relationships were superb.

What was done during the past year is not nearly so important as what might have been done or yet remains to be done. It is to future progress of our profession that I want to devote the remainder of this report.

Out of the experiences of the past year and prior years, the following conclusions have been reached:

- There is a great need for general planning for the future affairs of our Society. For example:
- (a) We should have in view the leadership of our profession at least three years ahead and that leadership (not specific individuals) should be thoroughly processed

and developed into a philosophy that will harmonize with the many changes affecting the profession.

- (b) The present prospects are that Kentucky will be the "hosts" to the Southern States Accounting Conference in 1958. Plans for the place of holding that conference should be laid out and committee organization for this project should be formulated in the immediate future.
- (c) The American Institute's policy as to its committee appointments is a matter that needs a continuing study and appraisal with the purpose of planning a forceful representation from Kentucky.
- (d) It should always be remembered that no organization stands still for long. As membership increases the organization should become more dynamic.
- 2. A good Society publication appears be justified and needed.
- 3. The accounting profession has a big stake in the economy of this Commonwealth. The profession should be alerted to cooperating in building sources of risk capital for small and young businesses.
- 4. Our relationship with the practicing public accountants should be strengthened and improved. It is a matter of logic that two groups working under the same law, code of ethics, and public service should find some way of uniting in these activities.
- 5. Advance planning to insure the continuity of committee activity.
- 6. We could do much more in liaison and coordination with other organizations beginning with our American Institute, including Chamber of Commerce, Bankers Groups, Credit Men, other accounting groups and various civic organizations.
 - 7. Better attendance at meetings.
- 8. Constant cooperation in furnishing at for American Institute committees ich as Federal Taxation and Advisory ervices to Local Practitioners.

Again I express thanks to the Directors, fellow officers, Committee members and staff who have done so much toward help-

ing through the year. What we have accomplished may not have been all that was desired, but the attitude and good feeling by all that prevailed in the attempt to accomplish something is all that could be desired.
