## Presidents Message

#### Poll of Membership Regarding Direct, Uninvited Solicitation

At the request of some of our members, you were sent a letter from the KSCPA Executive Committee offering you an opportunity to express your desire to retain or delete the provisions regarding direct, uninvited solicitation in the Code of Ethics of the State Board of Accountancy. The vote was 607 to retain and 385 to delete. This clearly demonstrates that the belief of Kentucky CPAs that we are not in agreement with the results of the mail ballot of the AICPA earlier this year, is valid. This information has been referred to the State Board of Accountancy for their consideration.

## Farewell To The Kentucky Accountant

With the introduction of *The Bottom Line for Kentucky CPAs* as our newsletter, we bid farewell *The Kentucky Accountant* as the title of our monthly newsletter.

The first edition of *The Kentucky* Accountant was printed in January, 1949. Gordon Ford was our President, and Earle B. Fowler was the Executive Secretary and Editor of the newsletter.

The front page carried congratulatory messages from Percival F. Brundage, President of the American Institute of Accountants, and John L. Carey, the Executive Director of that organization, which, of course, is now the AICPA.

Inside that first issue was "The President's Page," the forerunner to our "President's Message." It was written by then President Gordon Ford and we intended to paraphrase it in this issue of the new newsletter. However, in attempting to do so, we couldn't help but be impressed with how applicable his comments are even today, and we thought you would enjoy reading the whole article.

"Publication of the first issue of The Kentucky Accountant, bulletin of the Kentucky Society of Certified Public Accountants, represents a significant advance toward more effective

## RECENT ACCOUNTING RELEASES, INTERPRETATIONS AND EXPOSURE DRAFTS

#### Interpretation on Deferred Income Taxes

The FASB recently issued a proposed interpretation of APB Opinion No. 11, "Accounting for Income Taxes." This proposed interpretation is meant to clarify balance sheet classification of deferred income taxes as they relate to long-term construction contracts, undistributed earnings of subsidiaries, and a change in method of accounting for income tax reporting. The proposal would require that the deferred income tax be classified the same as the related asset or liability.

#### Contingent Rentals

The FASB has issued Statement No. 29, "Determining Contingent Rentals," which is an amendment to its Statement No. 13, "Accounting for Leases." The statement defines contingent rentals as "the increases or decreases in lease payments that result from changes in the factors on which lease payments are based after the inception of the lease."

#### Real Estate Industry

The AICPA's Real Estate Accounting Committee has issued an exposure draft entitled "Accounting for Real Estate Acquisition, Development, and Construction Costs." The proposed Statement of Position deals with cost capitalization other than the costs clearly associated with acquisition costs, carrying costs, indirect project costs, amenities, incidental operations, allocating capitalized costs to components of a real estate project, revisions of estimates, costs in excess of estimated net realizable value, abandonments and changes in use, and cost of sales. Comments should be received by September 28, 1979.

#### Accounting and Auditing Conference Scheduled For Lexington In November

The Society, in cooperation with the University of Kentucky, will present a two-day Accounting and Auditing Conference in Lexington on Thursday and Friday, November 1-2, 1979.

Society members Nancy Baldwin, with Potter & Company in Lexington, and Levis McCullers, of the University of Kentucky's accounting department, are serving as co-chairmen of the event which will feature at least 12 hours of outstanding technical programs. All programs will be developed and documented to meet the requirements for CPE accreditation.

The Conference will be held on UK's campus and convenient transportation will be available to and from the Lexington motel selected to house participants.

Saturday, November 3, is Homecoming Day at UK and the Society has a very limited number of tickets to the UK-Bowling Green game for that day. Tickets will go on a first-come, first-serve basis when the registration forms are mailed, which will be soon. For now, note the dates, November 1-2, and plan to take advantage of this excellent program and help us make the first Conference a big success.

#### Living With Inflation: New Public Relations Campaign

## Results of Opinion Poll on Direct, Uninvited Solicitation

During June-July, the Society conducted, by mail, an opinion poll of our membership to determine reaction to the recent action by the AICPA in deleting the ban against direct, uninvited solicitation from their Code of Ethics.

Specifically, members were asked whether or not they felt the Rules of Professional Conduct of the State Board of Accountancy of Kentucky should be amended to delete the prohibition on direct, uninvited solicitation.

At their meeting on July 20, the Executive Committee reviewed the results of the polling, which showed 607 votes in favor of retaining the rule and 385 in favor of deletion. The Committee has forwarded the results of the poll to the State Board of Accountancy.

containing legislation which, if enacted, would give taxpayers various credits for energy conservation and production expenditures. Included in the proposals are provisions which would offer the following:

- Tax credits for the purchase and installation of high-efficiency, wood-burning stoves,
- 2. Tax credits to provide stimulus for the development of shale-oil, solar energy, and small scale hydroelectric power, and,
- Make the current gasohol exemption from federal gas tax permanent.

#### Pitfall to Avoid:

The allocation of part of the purchase price of a business to a covenant not to compete must be specifically provided for in the sales contract according to a recent decision by the Tax Court.

In Lazinsky (TC, CCH Dec. 36, 135) the court denied the taxpayer an amortization deduction under § 167 based upon the life of the "covenant," because the "intent of the parties" as shown in the sales contract (which provided no such allocation) was binding unless the purchaser could present "strong proof" to the contrary. Due to the adverse interests of the parties to the contract (seller will treat goodwill as capital gain but a covenant generates ordinary income treatment) the IRS and the courts will generally accept the taxpayer's allocation provided it is contained in the sales contract.

unification of the accounting profession in our great Commonwealth. During the past year, an office of the Society has been established and an executive secretary has been employed. All of these things have been discussed for many years, but due to the small number of members, lack of money and other factors, they had not been feasible. Your officers and directors feel certain that you are pleased with the progress which the accounting profession is making in Kentucky.

We hope that you will contribute to the development of this bulletin as an authoritative source of information for and about the accounting profession in Kentucky by sending in items of news, interesting case studies involving your work or the work papers and other tools which you have found helpful, references to books and periodicals which contain valuable aids to the accountant and other information which may be of interest to fellow members of our profession.

From time to time some CPA who is not a Society member or some member who lives out in the State inquires 'Why should I belong to the Kentucky Society? What do I get for my dues? In my judgment, every Kentucky CPA should be a member of the Society. While every CPA has an obligation to the Society, the Society also has a very definite obligation to the CPAs of Kentucky, and in their efforts to fulfill this obligation, all of your officers and directors are motivated by a desire to accomplish, to the greatest possible extent, the purpose of the Society, as set out in the by-laws. These are:

"... to unite for common purposes the certified public accountants under the laws of Kentucky; to promote and maintain high professional and moral standards; to safeguard the interests of the profession; to advance the science of accountancy education; to secure proper recognition of the practice of accountancy as a profession; and to encourage cordial relations among accountants."

Because the American Institute of Accountants has done such outstanding service for the accounting profession at the national level, it seems to us noteworthy that the stated purposes of our State society are almost identical with those of the Institute. If we succeed in serving the accountants of Kentucky as well as the Institute has served the accounting profession throughout the nation, we shall feel that we have kept faith with you.

Right now and for many months past, a Society committee of 'top drawer' CPAs has been working with a committee from the Bar association on a working agreement between the two professions. Progress is being made. Society committee's work is invaluable to the individual CPA, yet it is but one of the many services of the Society to its members.

The all-embracing obligation of your professional society to you as a member is implied in these words of John L. Carey, in his book, Professional Ethics of Public Accounting: 'The very existence of the accounting profession depends on public confidence in the determination of certified public accountants to safeguard the public interest.'

That great obligation is to build and maintain public confidence in certified

public accountants.

Two basic factors enable us to approach our task with complete assurance: (1) Kentucky Law, administered by the State Board of Accountancy, requires that any person granted a Kentucky certificate must be well-qualified, and (2) rigid adherence to high ethical standards has been characteristic of the accounting profession in Kentucky since the first certificate was issued in 1916. Logically, then our program is: (1) To defend the legal status of the CPA certificate from attack by individuals or groups who may seek to weaken it by lowering the entrance requirements, and to make positive recommendations for improving our law when advisable, (2) To encourage members of the Society to become thoroughly familiar with the code of professional ethics and to assure the maintenance of ethical standards by taking prompt disciplinary action with respect to any reported violations of the code, (3) To encourage Society members to give more time to public service and civic activities, and (4) To engage in a public relations program designated to bring about greater public understanding, appreciation and
