Board approves UAA action for 2000 General Assembly

On June 7, 1999, the Board of Directors gave final approval to several amendments to Kentucky's public accountancy statutes for introduction in the 2000 session of the General Assembly. The amendments will bring Kentucky's accountancy law closer to the Uniform Accountancy Act that has been developed by the American Institute of CPAs (AICPA) and the National Association of State

Boards of Accountancy (NASBA). Here are the major features of the legislation.

- Streamlines the process for CPAs from outside the state to enter the state to practice.
- Allows CPAs to use their professional designation regardless of where or for whom they work.
- Allows non-CPAs to have an ownership interest in a CPA firm provided that interest does not

exceed 49 percent of the financial and voting interest of the firm. Such non-CPA owners must take an active role in providing professional services to clients of the firm.

 Adopts a uniform, one-year experience requirement for earning the CPA certificate, with an additional experience requirement that must be satisfied before a CPA

The first KSCPA newsletter in 1949 was called "The Kentucky Accountant," so it's fitting now in our 75th anniversary year to reach back to our past as we embrace the future. Our goal in making these changes was to help us get important information to you in a more user-friendly, timely, and efficient manner.

I'm confident that most of you already know the major items that the board will be working on in the coming year. Ushering the Uniform Accountancy Act through the legislature will be a top priority. The Act, which should be ready for the Kentucky General Assembly in January 2000, affects how CPAs will practice in Kentucky in the future. Principle revisions relate to how CPA firms will be owned (non-CPA ownership will be

allowed), and how CPA firms will be styled to the public. Other

streamline the process for CPAs to
practice in other states.

The next major item is the AICPA "vision" process. In my opinion, the vision process has more to do with repositioning the profession in the eyes of the public than it does with changing the way we practice. The vision process and statement simply recognizes that CPAs have provided, and will continue to provide, services far beyond the traditional tax and audit services. The goal is to ensure that both the profession and more importantly, the public recognize this as well.

Finally, we will begin the process of repositioning the Society to reflect the changes inherent in the new law, the new Uniform Accountancy Act, and the vision process. As we enter the new millenium, we have a great opportunity to build on past accomplishments and create new initiatives to better serve you, our members. To do this, we are implementing a strategic planning process that will unfold between now and the end of 1999. As we enter this process, we want and need your ideas, suggestions, concerns, and yes, even complaints. For instance, what do you think of this new newsletter, "The Kentucky CPA"? By working together, we can continue building the kind of Society that will be an invaluable resource to all of us.

Frequently asked questions about membership renewals

By now, you should have received your membership renewal notice. You will notice some questions on the front of the notice and a short Member Profile Information request on the back. Please be sure to complete this form when submitting your renewal. This information will provide the Society with additional methods to better serve our members.

Here are some of the more commonly-asked questions and answers regarding payment procedures and membership classifications.

Q. What period does my renewal payment cover?

A. The Society's fiscal year is July I through June 30. New applicants for membership are processed monthly. If you are a new member, your membership fee will be automatically pro-rated on a monthly basis.

Q. What is the deadline for paying my annual renewal?

A. Renewals are payable by

August I, 1999. Any member whose annual renewal remains unpaid after 90 days will be subject to termination by the Board of Directors.

Q. Are any concessions made for renewing if I am unemployed?

A. If you are a regular (certified) member who has temporarily left the work force for military duty, unemployment, disability or domestic responsibilities, and are not seeking full-time employment at this time, you may qualify for "inactive status" and pay a lower rate. Eligibility for this status is re-established annually before renewals are processed. Please call for approval.

Q. If I work in private industry, but do a few tax returns on the side, does that put me in the public practice category?

A. No. Your billing class is determined by your *primary* occupation, which you choose.

Q. Am I obligated to make a \$15 contribution to the KSCPA's Political Action Committee (PAC)?

A. No, but all members are encouraged to voluntarily support this very important part of our state legislative effort. The \$15 contribution to the KSCPA Political Action Committee is only a suggested amount; you may contribute as much or as little as you wish.

Q. How do I change my membership billing classification?

A. To change your membership billing classification, choose your new classification from the back of your renewal statement, cross out the old one, and send in the correct amount for the classification you have chosen. Be sure to provide us with the new information about your employer.

Q. I will be changing employment within the next 30 days. What do I pay?

A. Pay the amount for your new employment category. Be sure to note when you will change jobs and provide us with your new business name and address.

Q. Is my Society renewal tax

deductible?

A. The Omnibus Budget
Reconciliation Act of 1993
eliminated the deductibility of the
portion of membership renewal
used for lobbying purposes.
Renewal fees may still be partially
deductible as a business expense
(not as a charitable contribution).
Reduce the total amount by 10
percent (the estimated percentage
of dues revenue allocated to
lobbying activities) to calculate the
allowable deduction.

Q. I am retired. Is there a special membership category for me?

A. You're eligible for Life Membership if you have reached the age of 65 years or you are substantially retired from your fulltime occupation and have been a member for 15 years or more. We have two classifications of Life Membership. If you would like to receive all the mailings the Society issues, the annual fee is \$35 per year. However, if you would like to maintain your membership and not receive mailings, there is no annual fee. Please request Life Membership in writing. State that you meet the requirements listed above and indicate membership level you've chosen.

Q. What is the number printed after my name on the statement?

A. This number is your Society member number. We will be printing this number on all labels, confirmations and statements from now on. Later this year, our website will have a special member's only section which will require your member number and a password, so become familiar with your number now.

n sign or authorize someone so sign the accountant's report on financial statements. The one-year experience may be earned in industry, education, government or public accounting. The additional experience requirement is set out in professional standards and shall be inspected as part of the firm's normal peer review process.

- Reduces the statutory CPE requirement for CPAs in public practice to 60 hours every two years, which is the same now required for CPAs who are employed full-time in industry, education or government.
- Requires all CPA firms that prepare or offer to prepare compilation, review or audit reports to enroll in and participate in an approved peer review program that equal to the program established by the American Institute of CPAs

and administered by the Society. The Kentucky State Board of Accountancy will have authority to establish an independent oversight body that will have complete access to the peer review files of the Society or any other organization

offering peer review services in Kentucky. The role of the oversight board will be to provide assurance to the State Board of Accountancy.

- Provides that only those CPA firms performing or offering to perform attest services for the public shall be required to hold out as a CPA firm. CPAs in public practice but limiting their practice to non-attest services such as tax and financial planning may operate under names such as "Anytown Financial Services."
- Eliminates the requirement that the State Board must publish annually a register of all licensees. Instead, the State Board will provide this information to licensees and to the public via the State Board website.
- Adds an "administrative fine not to exceed \$1,000" to the list of sanctions available to the State Board when dealing with a licensee who is found, after administrative hearing, to have violated a regulation of the Board.

The Society will proceed to meet with legislators who are prospective sponsors of the legislation. Depending on the time necessary to place the amendments into legislative form, we may or may not have the bill ready for introduction during the interim legislative session this fall. In any event, the contents of the bill will be a major item of discussion at the Society's Legislative Key-Contact Conference on October 27, 1999, at the Holiday Inn in Frankfort.
